Define ‘textbook method of teaching’.

Textbook method of teaching is an instructional approach in which the textbook is given the chief importance. The teacher explains the subject-matter of the textbook. In this way, the content of the textbook is transmitted to the students so as to bring about changes in the behaviour of the students.

Define ‘discussion method of teaching’.

Discussion method of teaching is an instructional approach in which the students and the teacher exchange their academic views for the realization of the instructional objectives.

Wood’s dispatch refers to those recommendations of education suggested by the British Government which Charles Grant sent to the Company in 1854 in the form of a “Dispatch”. These recommendations of Charles Wood are also regarded as the “Magna Carta of Education”.

Aligarh Institute Gazattee was a weekly journal which would be published under the Scientific Society. The aim of this journal was to make the English Rules aware of the feelings of the Indians. This journal would be simultaneously being published both in Urdu and English language.

Sir Syed Ahmad founded a college at Aligarh in 1877 named M.A.O, college. This college was inaugurated by Lord Lytton. The renowned Muslims and British were teachers in this college.
